Organisation

ICROFS is founded by the Ministry of Food, Agriculture and Fisheries of Denmark. ICROFS is headed by an international board of directors with representatives from Asia, Europe, Africa, North America, the international federation of organic agriculture movements, IFOAM, as well as Danish universities and organisations.

Danish research

The current programme in Danish organic research is [Organic RDD](#). It consists of 11 projects and has a budget of €12 million. A new research programme, Organic RDD 2, has been announced and will run from 2014-2018. Both programmes are coordinated by ICROFS. An appointed Danish programme committee advises on ICROFS' national activities.

European Research

ICROFS has a long track record regarding participation in EU Framework Programme research projects.

We coordinate the transnational research programme for organic food and farming, CORE Organic. The collaboration is funded by the European Commission, and the research initiated is funded by the national ministries. So far, 21 research projects have been initiated with a total budget of € 22 million. Find out more at:

ICROFS also participates in EU projects such as SOLID, a European project on Sustainable Organic and Low Input Dairying. In these types of projects we coordinate dissemination and communication of progress and results.

International activities

ICROFS coordinates and participates in international research activities. One of these is the project Pro-GroV – Productivity and Growth in Organic Value-chains, which focuses on improving productivity and growth in organic value chains in Uganda, Kenya and Tanzania. ICROFS also collaborates with various international research institutions on joint seminars, conferences etc.

ICROFS actively contributes to the development of strategic research agendas, for example through TP Organics.

Information and publication activities

ICROFS considers dissemination and sharing of information vital for the development of the organic sector. We publish a broad range of information materials both in print and online.
